Town Council Regular Meeting

October 1, 2013 at 6:00 p.m.

Council Chambers – Springdale Town Hall, 2915 Platt Springs Road

The media and public were duly notified of the date, time, and place of this meeting.

MEMBERS PRESENT: Mayor Pat Smith, Mayor Pro-Tem Manos, Councilmembers Hallman, Reeley, Ricard, Sox-Peters and Wilkerson, Town Administrator Erica Barton, and Town Attorney Danny Scott.

I. Call to Order

Mayor Smith called the meeting to order at 6 p.m. A quorum was present. Councilmember Hallman provided the invocation.

II. Approval of Minutes

A. Council, on motion by Mayor Pro Tem Manos, seconded by Councilmember Reeley, voted unanimously to approve the September 3, 2013 meeting minutes.

III. Old Business

A. Consideration of O-13-09; An ordinance to amend the Ch. 1 General Provisions of the Code of Ordinances. Council, on motion by Councilmember Wilkerson, seconded by Councilmember Sox-Peters, voted unanimously to approve O-13-09: An ordinance to amend Ch. 1 General Provisions of the Code of Ordinances. IV. New Business

A. Consideration of R-13-09; a resolution to approve an agreement with LRADAC for the purposes of the Rise Above it Coalition initiative. Council, on motion by Mayor Pro Tem Manos, seconded by Councilmember Sox-Peters, voted unanimously to approve R-13-09.

B. Consideration of R-13-10; a resolution to approve an agreement with SCE&G to lease pedestrian lights along Airport Blvd. Council, on motion by Councilmember Wilkerson, seconded by Mayor Pro Tem Manos, voted by a margin of 6 to 0 to approve R-13-10. Councilmember Ricard abstained from voting because he works for SCE&G.

C. Reschedule the November 5, 2013 Town Council meeting to November 12, 2013. Council, on motion by Councilmember Sox-Peters, seconded by Mayor Pro Tem Manos, voted unanimously to change the date of the November Town Council Meeting from the 5th to the 12th.

A. Administrator Barton referred Council to her monthly report and commented on the building inspector situation in the Town.

B. The Public Works Director's report was received as information by Council.

C. Chief Cornett reviewed his monthly report and statistics with Council.
