Town Council Regular Meeting

March 13, 2012 at 6:00 p.m.

Council Chambers – Springdale Town Hall, 2915 Platt Springs Road

MEMBERS PRESENT: Mayor Pat Smith, Mayor Pro-Tem Gus Manos, Councilmembers Jacob Wilkerson, Nancy Sox-Peters, and Steve Hallman, Town Administrator Erica Barton, and Town Attorney Danny Scott.

MEMBERS ABSENT: Councilmembers Juston Ricard and Kevin Reeley.

I. Call to Order

Mayor Smith called the meeting to order at 6pm. A quorum was present. Springdale Baptist Church Pastor Tommy McGill provided the invocation.

II. Approval of Minutes

Council, on motion by Mayor Pro Tem Manos, seconded by Councilmember Wilkerson, voted unanimously to approve the February 7, 2012 regular meeting minutes.

III. New/Old Business

A. Judge George Nicholson swore in Kevin Cornett as the Police Chief for the Town of Springdale. Mayor Smith recognized Chief Randy Scott, City of Columbia, for his participation in the selection of the new Chief for the Town.

B. Rod Dooley, Sr. presented the FY11 Preliminary Audit to Council.

C. Administrator Barton updated Council on the recommendations made by the Planning Commission with regards to text amendment O-12-02; an ordinance amending the Parrish Plantation PDD; removing the requirement for the installation of a turn lane on Wattling Road into Parrish Plantation; adding a requirement to install common area amenities. Wade Caughman presented on the status of the project requirements that the Planning Commission recommended. He stated that everything that is difficult has been completed. Council accepted the information as presented.

D. Council agreed to provide a \$500 sponsorship from the Accommodations Tax Fund to the WIMG annual conference and to sponsor a table at the Airport High School Educator Gala.

The Chief referred Council to his monthly report and statistics.
